If a bill of lading is issued and describes the charterparty, the terms of which are incorporated, the charterparty terms will apply if the holder of the bill of lading is also the charterer. For a third party holder of a bill of lading, the terms of the bill of lading will apply, especially if they are subject to the Hague Rules or Hague-Visby Rules.
